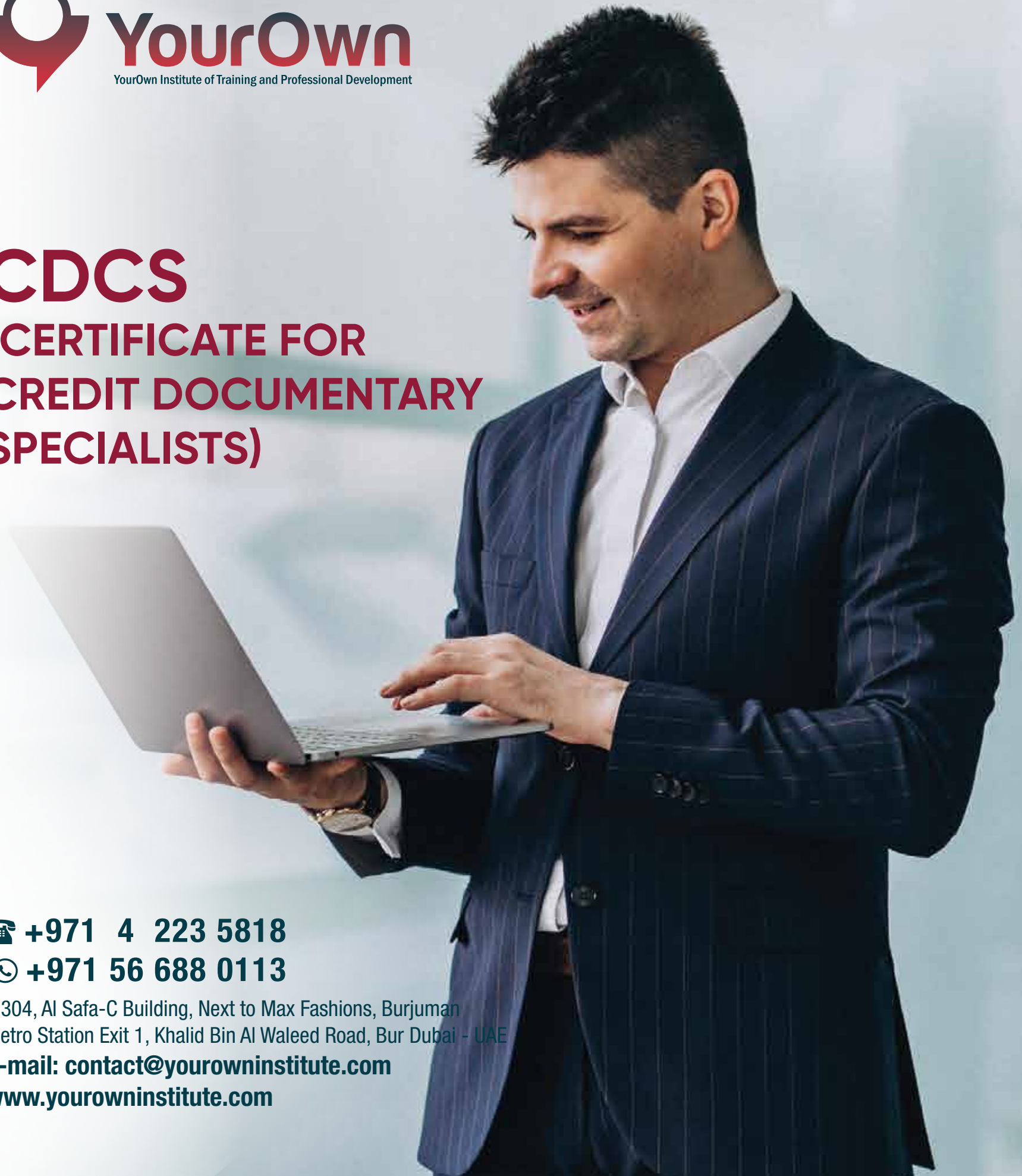

 - ◆ A total of 100 marks are available. The pass mark for the examination is 70% of the available marks; you must also achieve 60% of the marks available in section B to pass the qualification. The structure of the assessment ensures that all aspects of the course content are subject to external examination under strict examination conditions. Qualification grading the overall qualification will be graded Pass/ Distinction. You must achieve a mark of 70% overall (and 60% for Section B). The qualification grade boundaries are as follows:
